# EU General Data Protection Regulation (EUGDPR)

**The EU General Data Protection Regulation (GDPR) is new legislation that provides a single, harmonised data privacy law for the European Union.**

The GDPR has replaced the old Directive and is directly applicable from 25 May 2018 in all Member States. The GDPR will affect every organisation that processes EU residents' personal data.

This EU General Data Protection Regulation (GDPR) training course also imposes obligations on companies to not only document and safeguard information on identifiable living persons but companies must also be able to evidence compliance.

With the increasing risk of data breaches and cyber-attacks, the GDPR aims to prevent the loss of personal data by improving data security for all individuals living in EU member states.

### What this course provides

This is a comprehensive one-day course which will provide attendees with a clear understanding of the new law and the practical expectations required from companies and staff who process personal data under the new EU GDPR.
